Self-indictment supplement - January 5, 2025

The following facts regarding the commission of the offenses of unauthorized masturbation and/or ejaculation are undisputed as is the fact that the offenses occurred.

Undisputed facts:

On Thursday, January 2, 2025 I applied to join the Womania Empire seeking to be accepted as the property of Her Majesty, Empress Patricia I.

On Friday, January 1, 2025 I filed a mandatory self-indictment for my past offenses and crimes. This case was accepted by the Court on January 4, and I was duly notified by the Honorable Baroness Gabrielle von Malendorf in her capacity as Authorized Court Lady Officer. My Case No. is RCR0082 and was made publically available on January 4, 2025, the details of the case were also published in the Womania News of the same date.

On Friday January 3, 2025 I was advised that my application for acceptance as a State slave was awaiting the approval of Her Majesty, Empress Patricia I. My application was accepted on January 4, 2025 and on that date I received State slavery certificate No. 0100.

On Thursday January 2, 2025 I applied for a one time Permission For Masturbation With Ejaculation. On Friday January 3, 2025 I received notification from the Honorable Baroness Gabrielle von Malendorf that I had been granted certificate Registration Number PM03012025-1. This news was also published in the Womania News on January 3, 2025.

The email from Baroness von Malendorf admonished that it was a onetime use only and provided information about how to about new Permissions. The certificate I received contained the following language: "Masturbation or ejaculation without the permission of your Lady-Owner or Womania Empire is a criminal offense!"

Upon receipt of my State slavery certificate I read, and fully understood the "State Slaves Obligations"; specifically I read and understood section 4, which reads "Must not masturbate or ejaculate (cum) without Permission. He must apply for this Permission by email at the Empire Office." I read, and understood the mandatory nature of this obligation.

On Friday January 3, 2025, before I had received my Permission for Masturbation, and prior to being declared as the property of the Empress, I masturbated and ejaculated on three occasions.

The above are the facts, and are not in dispute.

I immediately contacted Baroness Gabrielle von Malendorf to advise Her of my actions. I had hoped these offenses could be dealt with under my active case RCR0082; She advised me that I would need to file another self-indictment, which I have now done.

In hopes of offering some mitigation for my actions I beg the Court to consider the following: At the time of my offense I had not yet been advised that I would become State property, and I had not yet received my Permission containing the warning noted above.

At the time I had filed a self-indictment and was waiting to hear if the Court was going to proceed against me. I had read through the 80 or so publicly available records of judgments in previous

cases and I was very aware that I was facing the possibility of severe punishment. I masturbated out of fear and worry for what the future might hold.

In my reading I came across one case... Case No. RCR 006/17 where the Court ruled that it was not a crime to masturbate while viewing OWK films related to punishment in the OWK underground prison. Whilst I would never suggest that this decision is binding upon the Court, nor would I dare to suggest that it is analogous to the current situation, I would respectfully argue that these situations are so similar to the degree that the Court should rule that my behavior did not rise the level of a criminal offense. I acknowledge that this case appears to be in the minority and that most cases support a finding of guilt combined with an element on corporal punishment; however, this Court

I concede that the bulk of the legal authority weighs heavily against any leniency this Court may be inclined towards; however, I would respectfully argue that at the time of the self-confessed crimes/offense I was not yet a State slave, nor was I the official property of Her Majesty, Empress Patricia I.

In addition to the above I would ask the Court to consider the self reporting nature of any potential indictment.

Furthermore, by way of mitigation I have voluntarily placed myself into chastity – I have included a photograph by way of proof and will gladly provide any additional information required by the Court.

In my communications with the Honorable Baroness Gabrielle von Malendorf it seems that I may have inadvertently committed the following serious crimes and or crimes:

- 1. It has been brought to my attention that the correct form of address for Baroness Gabrielle von Malendorf is, in fact, "Your Divine Excellency, Baroness Gabrielle von Malendorf" I freely acknowledge that I have failed in this respect. Furthermore, I understand that my failure to properly address a high ranking official of the WE rises to the level of a Serious Crime in that my behavior may "Ignore or Question the Superiority of Women" specifically, I failed to acknowledge the Baronesses' duly earned, and rightful honorific title. I acknowledge that ignorance is no defense.
- 2. I believe that in failing to refer to Baroness Gabrielle von Malendorf by her correct title I may have violated §1 of the Basic Principles in that I may have caused harm to the Baroness by failing to use her full and correct title a Serious Crime.
- 3. I acknowledge that failing to refer to Baroness Gabrielle von Malendorf by her correct title in my communications may rise to level of violence against a Woman in that my actions in failing to recognize the Baroness' correct form of address are inexcusable
- 4. Disrespectfulness to the Imperial Authority per the criminal code this offence is complete when the accused is disrespectful to a Female person who represents or acts on behalf of the Office, said crime is committed by a failure to "greet properly."
- 5. Approval of the Degradation of Women: in that I failed to use the correct form of address when corresponding with the Honorable Baroness Gabrielle von Malendorf

6. Disrespect Against Women – the code codifies the offense of Disrespect Against Woman by stating as follows - A male person who behaves disrespectfully in personal, written, or other contact with a Woman **must** be punished for committing an offense. Under this section, failure to address Baroness Gabrielle von Malendorf by her correct honorific is an offense punishable by law.

I respectfully submit to the Court that there are extenuating circumstances that favor no criminal prosecution and/or punishment in this case.

With that said, I freely and voluntarily acknowledge the transgressions, offenses and crimes committed against the Person of Baroness Gabrielle von Malendorf.

Furthermore, by way of mitigation I have voluntarily installed a chastity device upon my person, I will provide the key to whomsoever the Court orders.

I respectfully request that the Court combine this matter with my current case Case No. RCR0082.

While it is my fervent hope that this Court does not impose a sentence of corporal punishment, it is my humble and respectful request that if the Court does impose a corporal punishment that this slave may seek execution of said sentence through locally available channels, subject to court approval.
